Our membership base grew once again in 2018. The CITMA Paralegal category seeing particularly strong growth. It is pleasing to see the profession's support for CITMA continue to grow.

As an organisation we remained committed to working on consultations and championing the profession's position on changes within the sector.


IP Inclusive added a new initiative to its excellent work within our profession - Careers in Ideas. The new offering hopes to inspire a new generation of IP professionals.

2018 in numbers





What we do and our vision

Our vision is to be the pre-eminent UK organisation in the development, promotion and protection of the trade mark legal profession. We want to be valued by our members and seen as an important source of professional knowledge in the field of intellectual property law, with a focus on trade marks and designs.

We have three strategic objectives:

- To be the pre-eminent body for trade marks and designs in the UK
- To represent, promote and engage the membership and the wider profession
- To equip and support our membership to be competitive and successful

How we are governed

We are governed by a Council of elected representatives. Made up of volunteers, it oversees and makes key decisions on the business and strategy of CITMA.

Beneath the Council sits a number of committees, which are directed by the Council to deliver certain elements of CITMA's work. Committees delegate tasks to working groups, particularly around the delivery of certain projects and work streams.

Our Council and officers are elected from among the corporate membership and serve a two-year term.

A change to the officer positions was agreed in 2018. The Second Vice-President and Treasurer positions were merged.

Tania Clark was elected as President in April 2018, following Kate O'Rourke reaching the end of her term and therefore moving into the Immediate Past-President position. Richard Goddard was elected as First Vice-President and Rachel Wilkinson-Duffy as Second Vice-President/ Treasurer.



The committees in 2018 were:

Education Policy & Development

The committee oversees and seeks to develop the education programme for members.

Events

Leads on our events programme, leading the direction for the 50+ events CITMA holds for members every year, ensuring quality and relevance to members

Executive

Oversees and scrutinises finance, governance and the core business of CITMA.

Law & Practice

Discusses impact of changes to IP law and practice. Responds to consultations and works closely with organisations including the Intellectual Property Office, EU Intellectual Property Office and World Intellectual Property Organization.

Publications & Communications

Oversees and scrutinises CITMA's communications and publication strategy. It also acts as a sounding board for campaigns and projects.

Finance

The Council maintains close control of the organisation's finances. Quarterly management accounts are produced and delivered by PKF Littlejohn LLP. These are scrutinised by the Chief Executive, Treasurer/Second Vice-President and Executive Committee.

The Executive Committee is also responsible for the general oversight of financial transactions and identifying any issues to the Council for further discussion or recommendation.

The management accounts and the fully audited set of annual accounts are signed off by the Council.

Regulation

We continued to fulfil our obligations as an Approved Regulator, as defined in the Legal Services Act 2007. We have achieved this primarily through overseeing the functioning of our regulatory arm – IPReg.

Brexit

CITMA continued to prioritise Brexit in 2018. Maintaining influence and keeping members informed of developments were key elements of our work.

With the UK due to leave the European Union (EU) in early 2019, we ensured that members were kept informed of all developments as soon as information was known.

We continued to lobby, engage and seek the support of key influencers in government, parliamentarians, and other IP and legal organisations.



Parliamentary engagement

With our business case hot off the press from December 2017, we started the year seeking to further engage MPs and parliamentarians.

We issued a call to action for our members to reach out to their MPs, sending them our business case and outlining the negative impact Brexit could have on our profession and businesses in their constituency. Our actions resulted in over 70 letters being sent and several meetings with constituency MPs followed, including some high-profile influencers.

We also saw parliamentary questions asked on our behalf, which drew responses directly from ministers from different departments.

In May 2018 we submitted evidence to the All Part Parliamentary Group on Legal and Constitutional Affairs on the impact of Brexit on the Chartered Trade Mark Attorney profession, as part of its inquiry on the effect of Brexit on the provision of legal services.

Our evidence was quoted in committee level in the House of Commons.

IP office engagement

Our strong working relationships with the UK Intellectual Property Office (UK IPO) and the EU Intellectual Property Office (EUIPO) have perhaps never been more important.

Regular meetings and dialogue with both have allowed us to influence and stay informed on the most pressing of matters related to Brexit. We have been able to help and offer our advice on technical proposals and general matters to ensure that burdens are minimised and there are no unintended consequences.

Updating our members

Supporting our members through Brexit by providing them with the tools to be as prepared as possible is a vital part of our work.

The UK Government and EU published several important papers outlining the future of intellectual property in the UK and EU post-Brexit.

We ensured that our members were kept up-to-date every step of the way by regular emails and website updates. Kate O'Rourke, who leads our Brexit Task Force, gave a talk on Brexit at our Spring Conference too.

The prospect of the UK leaving the EU without a deal became a greater possibility in 2018 as the clock ticked towards the 29th March 2019 deadline.

As the year progressed more of our work became focused on no-deal preparations, again keeping our members informed of every development.

Sharing our message

Sharing our message of reassurance was important. We spoke at several key events and conferences throughout the year - in the UK, across Europe and further afield.

Our President Tania Clark attended and spoke at events in Athens, Berlin, Dubrovnik, Vancouver, Seoul and Paris. Our message was shared globally.

We also made sure that our views were quoted in the media, with several contributed articles and quotes published in the legal and intellectual property media.



A digital transformation

In 2018 we delivered a new integrated website and database to provide a better and more effective service for our members. Working with two digital providers we launched our new system in October 2018.

Website

Our new website is designed to reflect our position as the voice of the trade mark legal profession.

We want to offer an excellent service to everyone who interacts with us – our new website enhances what we can offer.

Content is an important part of our communications strategy and the new website enables us to present and promote content in a completely new way – signposting users to content that is of interest to increase engagement.

Using content we can inform and entertain – promoting intellectual property and our members in the process.

Key new features

Enhanced directories

Our find a Chartered Trade Mark Attorney directory has been made much more powerful, and allows members to list specialisms, which the public can search by. We want it to be as easy as possible to link business owners and members of the public with our members.

Members can also add a photo and a bio to make it a more personal introduction to our member as well as being a better marketing and business development tool.

We have also improved our find a member tool – to help connect our network of 1,600 professionals within the UK and across the world.

Improved event bookings

Members can now be booked onto our events by someone else, even if they are not a member. We have also made it possible to book several people onto an event in one go.

Search our case comments

All the case comments published in CITMA Review since 2016 are now fully searchable and easier to find.

Earn CPD from past events

All recorded events dating back to 2014 are available to watch online - including webinars, lectures and some of our recent conferences and seminars.

Jobs board

Our jobs board has been enhanced and will continue to keep the profession up-to-date with the latest trade mark jobs.

Public facing content

We want our digital channels to promote intellectual property and the trade mark attorney profession. We are offering richer content to inform, educate and entertain the public on intellectual property and why it is important to get professional legal advice on their IP.

A new feature to deliver this is our blog - which will bring business and consumer focused insight into trade marks in an entertaining and engaging way.

Serving up the right content

The website works on a rulesbased system that is integrated with our database. We can segment who sees particular content on our website based on what we know about their preferences.

Database

Sitting in the background is a brand-new database. It is more powerful and enables us to better serve our members

Over time, we will use our data to learn more about our members and those people we interact with. This helps us to tailor what we offer to different groups and our membership as a whole.

Our new database also helps to ensure that we were compliant with new data protection laws (GDPR) that came into force in 2018.

CITMA Paralegals

Following the launch of CITMA Paralegal membership last year, we worked towards preparing for the launch of continuing professional development (CPD) for the new category.

The change recognises the work of these members and better reflects the important role they play in the trade mark and design legal profession. It also enables members in this category to use the title CITMA Paralegal.

One of the biggest changes is the introduction of a CPD element for CITMA Paralegals to fulfil.

Existing members had the option to opt-in to the scheme. Over 50% of those who needed to opt-in, did so. Everyone who passed the CITMA Paralegal Course and subsequently joined CITMA in 2018 was automatically opted-in.

Members on the scheme must complete eight hours' CPD, which will be self-certified. We issued guidance to members on earning CPD as well as a template to record their CPD on.

Paralegal representation on Council

This year we appointed our first ever paralegal representative to our governing Council. After a selection process Rebecca McBride from Pinsent Masons was appointed to the role.

Although the position does not carry full voting rights on Council, it does allow for paralegal input and influence at board level of CITMA for the first time.

Events for paralegals

Events are an important part of our offering to CITMA Paralegals. We held events, seminars and webinars specifically targeted at paralegal, administrator and formalities staff. These events were well attended.



Our CITMA Paralegal Seminar in October attracted a sold-out audience to discuss 'post registration'. It featured a strong line-up of experienced speakers including Julius Stobbs from Stobbs IP.

Membership growth

The launch of the new category and the upcoming commencement of the CPD scheme combined to see a significant growth in CITMA Paralegal membership. It was the membership category with the largest growth.

77 new members joined the category in 2018 to bring the total number of CITMA Paralegals over the 300 mark.

CITMA Paralegal Course

The CITMA Paralegal Course continued to go from strength-to-strength. 89 people passed the course in 2018, with 58 of those taking up free membership of CITMA for the remainder of the year.

We agreed and announced a change to the Course for 2019. It will now commence in September to align with the academic year.

Membership

We continued to grow our membership in 2018. The total number of members increased by 5% in 2018 to 1,688 – 67 more than the previous year.

We welcomed 156 new members during the year and additionally saw 38 upgrade their membership from Student to Ordinary following their entry onto the register of trade mark attorneys.

CITMA Paralegal continued to be a big growth area, with an increase in membership of 26%. The forthcoming launch of continuing professional development (CPD) was a big driver for this increase.

Events

We welcomed nearly 3,800 delegates to our 42 events in 2018.

In a more streamlined approach that focused on quality over quantity, we held fewer events in 2018. Our focus was on producing quality events that our members enjoyed and benefited from.


We placed an extra emphasis on webinars, which continued to be our most popular knowledge sharing CPD events. However, we maintained a regular in-person regional offering for members.

Our Autumn Conference moved venue within Birmingham to the ICC, and the larger venue attracted a bumper, sold-out, audience.

The Spring Conference also saw an increase in attendance. It attracted a global audience and speakers from around the world including Canada, Japan, Russia and Turkey.


The Christmas Lunch in London remained our most popular event, with some 560 guests.

The launch of our new website late in 2018 included a brand-new booking system, to make event registration simpler for members. New features included the ability to book multiple delegates on in a single booking and for bookings to be made by people other than the delegate themselves.



Law and Practice

Our Law and Practice Committee meets regularly to discuss the latest developments in intellectual property law. It leads on ensuring members are kept up-to-date and responds to consultations on behalf of the trade mark and design legal profession. The committee oversees a number of working groups.



Members of the committee's UK IPO liaison group continued, along with CITMA's officers, to attend the quarterly Marks and Designs Forum (MDF), a forum dedicated to trade mark and design law and practice, in addition to attending the UK IPO's stakeholder meetings.

As has now become a custom, the committee hosted termly visits by senior officers of the UK IPO to its own committee meetings, which provides CITMA with updates as to the latest and upcoming developments at the UK IPO.

In return, CITMA is able to raise directly with the officers of the UK IPO questions on matters of policy or particular points of practice that may be causing difficulty for the membership.

The committee has also continued to work with the UK IPO in connection with its marshalling schemes of Hearing Officers.

A meeting with the Appointed Persons was also hosted by the committee, in order to exchange feedback and explore the possibility of expanding the marshalling schemes to hearings before the Appointed Persons.

The committee continued to be involved in unofficial consultations with the UK IPO regarding the transposition of the Trade Mark Directive into UK law.



European Union Intellectual Property Office (EUIPO)

Our President, supported by our First Vice-President, attended the EUIPO's user group and anti-scam meetings. Other meetings in both Alicante and Brussels, including CP11 workstream 2 to which CITMA was appointed in July, were attended by the Committee's chair and members of the EUIPO liaison working group throughout the year.

Members of the EUIPO liaison working group also attended the EUIPO's Stakeholders Quality Assurance Panels meetings in January, April, July and October. The committee responded during the year to a number of EUIPO consultations and questionnaires regarding CP initiatives.

CITMA and the UK IPO assisted the EUIPO in holding the EUIPO British Day and legal reform workshops in December. This was supported by senior EUIPO officials and covered topics ranging from the EUIPO's future challenges, recent progress, 2020 strategic plan, updates on the European cooperation project and legal reform.

World Intellectual Property Organisation (WIPO)

WIPO's roving seminar for the UK was attended by the President and members of the WIPO liaison working group.

The committee's chair also attended the annual WIPO working group meetings in Geneva in June.

The group continued to collaborate with the IPO and WIPO throughout the year on substantive issues relating to international registrations, including ensuring that the issues raised within the UK position paper listing CITMA's priorities continued to be focused on by the international bureau as a short-term priority.

European Sisters Organisation

The annual meeting of the European Sister Organisations was hosted by CITMA in London in March and was attended by representatives from APRAM, BMM, GRUR, ECTA, MARQUES and UNION.

This annual meeting of European stakeholder associations, whose principal interest is in trade marks and designs, provides a useful forum for discussion of matters of mutual interest in the field.

Designs and Copyright

Following the popularity of the designs and copyright group's first seminar in 2017, the designs & copyright working group arranged for a further seminar to be held alongside CITMA's spring conference in 2019.

The group has run such seminars as and when suitable subjects arose and would keep the matter under review.

The group continued to liaise with the UK IPO concerning the status of unregistered design rights in the UK post-Brexit. The group welcomed the UK government's ratification of the Hague Agreement for the international registration of designs in 2018.

Litigation

The litigators' working group continued to attend the IP court and IPEC users committees and its review of IPEC Guidelines.

Organisation of the marshalling scheme with the IPEC judges was also continued and discussions regarding the possibility of expanding the marshalling scheme to High Court judges were initiated.

Other projects

The committee continues to review case referrals to the General Court and European Court of Justice. In respect of emerging markets, the committee responded to a consultation on changes to Chinese trade mark law and continued to liaise with the IPO attachés for China, South East Asia, India and Brazil.

Education

Responsibility for education is an important part of CITMA's role - we continue to monitor the route to qualification and offer paralegals the chance to develop their knowledge and gain a qualification.

Education

We monitor the route to qualification for aspiring Chartered Trade Mark Attorneys and the performance of those examination agencies accredited by IPReg. We want to make sure that the courses maintain the standards expected by CITMA, IPReg and the profession.

Despite IPReg being the only body that can provide formal answers to specific questions about qualification, CITMA assists in signposting as students make their journey to qualification.

CITMA Paralegal Course

CITMA's course continues to be recognised as the industry standard qualification for paralegals. The successful candidates picked up their certificates at a ceremony in London's Canary Wharf.

Lectures are delivered by experienced CITMA Paralegals and Chartered Trade Mark Attorneys. Topics covered include: how to register a trade mark, searches, renewals and maintenance, changes of ownership, oppositions, and cancellations.

The course also touches on registered designs and domain names.

89 people passed the 2018 course.

Student awards

We presented awards to top performing students at our Christmas Lunch in London.

The awards recognise high achievement on the courses for those qualifying as Chartered Trade Mark Attorneys at Bournemouth, Nottingham Trent and Queen Mary universities. Prizes were also awarded to the top scorers on the Nottingham Law School litigation and advocacy course and the CITMA Paralegal Course.

Nottingham Law School -Professional Certificate in Trade Mark Practice

There were 53 students in total, including four sitting assessments from previous years. 39 of these students passed first time.

Queen Mary University of London - Postgraduate Certificate in Trade Mark Law & Practice

50 students in total took the assessments, of these 94% passed after resits were taken into consideration. Five students received the higher classification of distinction and 13 received a merit.

Bournemouth University

49 students passed and of those 13 were on the trade mark attorney route.

Corporate social responsibility

IP Inclusive

Our commitment to diversity and inclusion in the IP professions continued via our support of the IP Inclusive initiative.

IP Inclusive was founded in 2015 by a number of IP organisations, including CITMA. It aims to improve access to the intellectual property professions, regardless of disability, age, gender, sexual orientation or social, economic and cultural background.

The initiative includes several support and networking groups for the IP profession. These include IP Out for the LGBT community, a support and networking group for women in IP and a group for ethnic minority IP professionals called IP & ME.

The support groups continued to be active, holding several events throughout the year.

A big development in 2018 was the announcement that trade mark and patent attorneys could now claim CPD hours for attending educational events organised by IP Inclusive.

The announcement followed the Intellectual Property Regulation Board (IPReg) updating its guidance on which activities qualify for CPD to include events organised by IP Inclusive.

Trade mark and patent attorneys are regulated by IPReg. To fulfil their CPD requirements they must complete 16 hours of qualifying activity per year.

We continue to support the running of IP Inclusive and are represented on its management board by Keven Bader and Richard Goddard.

Careers in Ideas

An initiative to inspire the next generation into a career in IP was officially launched in 2018.

An offshoot of IP Inclusive, Careers in Ideas has received a broad range of support from across the IP profession.

It has been created to grow the interest in a career within the IP professions amongst a wider and more diverse audience. It aims to support and inspire anyone

who might consider an IP career and those who support them in their choices including careers advisers, teachers and parents

The resources created by the initiative will be used in schools and for careers advisors and includes an information booklet, a poster and a presentation. The website also contains a host of materials to inspire individuals interested in their own career choices.

It is hoped to encourage ever greater diversity in the sector and to help young people make informed choices about careers in intellectual property.

IP Pro Bono

IP Pro Bono continued to provide support for individuals and small businesses involved in IP litigation, who are unable to afford professional advice.

We have been part of the scheme since its inception in 2016 and continue to support it.

Benevolent Fund

The CITMA Benevolent Fund continued to raise funds in 2018. Our annual charity quiz night raised money for the Fund, alongside the winning team's chosen charity.

There was no financial assistance provided to members of the Fund during the year.

Other activities

We continued to promote the services of Law Care, which supports mental health and wellbeing in the legal community. We provided Law Care with stalls at some of our main events including the Spring and Autumn conferences.

At our Spring Conference we once again supported London Wildlife Trust.

Communications

A brand-new website was a highlight in a year where our communications and engagement activities continued in a positive direction.

Social media

We continued to push our content out regularly on Twitter and LinkedIn. Engagement, being the most important measure, was encouraging.

We trialled using targeted promoted posts on Twitter to promote our content, particularly for events.

Once our new website launched we used paid for promotion to increase the reach and engagement in our content, particularly blogs.

The feedback on our promoted posts was positive, and we would seek to include in our future communication plans.

We passed the 3,000 follower milestone on Twitter in 2018.


Email communications

Our main engagement with members continued to be via email. We saw excellent engagement with our email communication, with an average open rate of 39%.

Via our new website we have a new email communications platform at our disposal which is due to be implemented in early 2019.

CITMA Review

Our magazine continued to be published by Think. It received a design refresh in 2018 to bring it more in-line with our brand guidelines and to give it a bit of a renewed look and feel.



PR & media engagement

Brexit dominated our media work, we ensured that we were providing comment on all the major developments throughout the year.

We achieved comprehensive and regular coverage in the intellectual property and legal media on Brexit. We were also able to get traction with a few publications further afield, including TalkRADIO.

Formal publications

We published the book Contentious Trade Mark Registry Proceedings in 2018. This followed on from bringing out a book on anticounterfeiting the previous year.

Authored by Michael Edenborough QC the publication is a comprehensive guide to the practice and procedure relating to contentious matters before the United Kingdom Trade Marks Registry. It is currently the only book of its kind.

Sales were strong in the first few months after publication. Legal bookshops Wildy & Sons and Hammicks both stocked the book.

Representing the profession

An integral part of our work is promoting and representing the profession by attending events to act as the voice for Chartered Trade Mark Attorneys.

Representing the profession



CITMA Council

The CITMA Council meets six times a year. It oversees and makes decisions on the business and strategy of CITMA.

In 2018 we introduced two new representative positions to Council - a student and a CITMA Paralegal. Although these two positions do not have voting rights, for the first time these groups will have direct influence at the highest level of CITMA.
